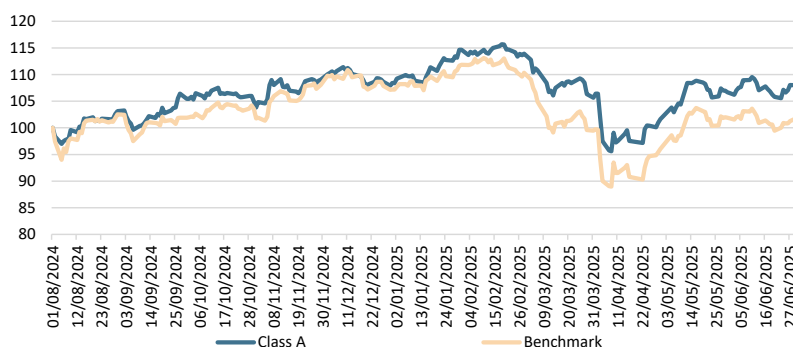

Manager's Commentary

The fund closed the month of June with a result of 1,27%, outperforming its benchmark index, which reached (-0,04%), and the main global, American and European indexes. It should be noted that the US dollar lost 3.7% of its value against the euro during the month, which had a negative impact on the portfolio, which has an exposure of close to 60% to the currency.

During the month of June, changes were made in the main 40 positions, which account for 70% of the fund's weight. Within the technology sector, the weight in Microsoft and Qualys was reduced in order to increase exposure to Dassault Systemès and Salesforce. In other sectors, we highlighted weight increases in Lowe's, Iqvia and Icon, financed by weight reductions in Rightmove, HCA Healthcare and Verallia.

On the sales side, six positions exited the portfolio, representing a turnover of 4.6% of the fund and contributing consolidated gains of 0.7%. Specifically, we sold Advanced Micro Devices (+34%), Etsy (+18%), Adyen (+18%), Kinaxis (+17%), Lam Research (+14%) and Resmed (+12%). The reason for all the sales is the ability to invest in better alternative ideas. At the end of the month, the fund was nearly 97% invested, with the remainder in cash.

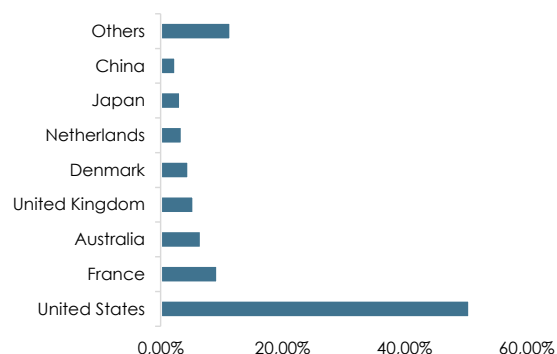

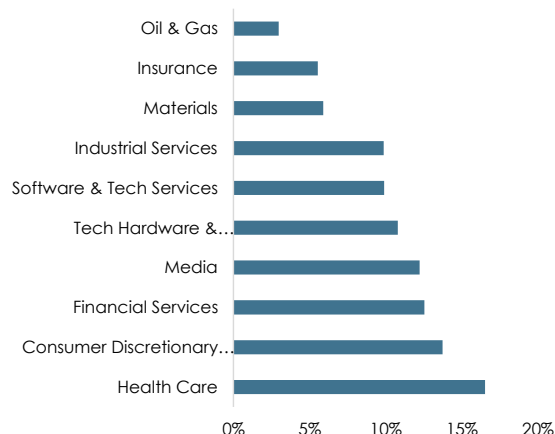

Countries allocation



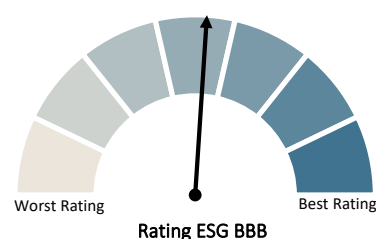
