Global investment fund which may invest 0-100% of the assets in financial CIS, whether harmonised or not (maximum 30% in non-harmonised CIS), whether or not belonging to the Management Company's group, and may invest up to 10% of the assets in alternative management CIS. Directly or indirectly through CIS, 0-100% of the total exposure shall be invested in equities or public/private fixed income, and may also have exposure to financial instruments whose performance is linked to dividends of shares or stock market indices of OECD markets, volatility and variance of equity indices of OECD countries, and to commodities. In both direct and indirect investments, there is no predetermination of issuers (public/private), market capitalisation, economic sectors, average duration of the fixed income portfolio or credit quality of issuers/issues, and the entire portfolio may be in fixed income of low credit quality (below BBB-) or even unrated. The issuers/markets will be from the OECD, and up to 50% of the total exposure may be invested in issuers/markets from emerging countries.

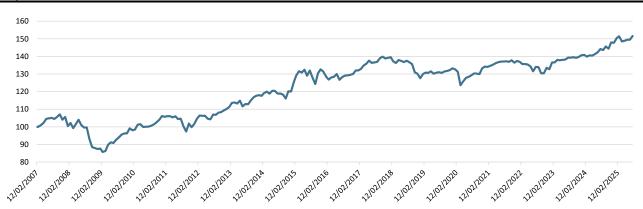

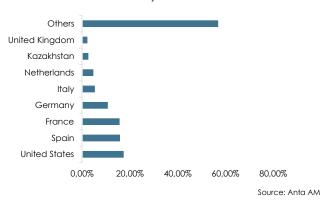

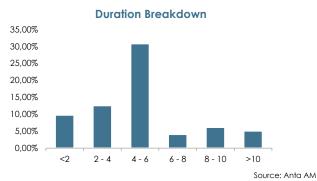
Sector allocation
