

#### **Manager's Commentary**

During August, the fund outperformed its benchmark index, reaching 0,04% compared to -0,20%. Credit tightened to its lowest levels of the year and the investment team currently sees no possibility of extra returns from spread compression at any point on the curve. Throughout the month, we slightly increased the duration of the portfolio above that of its benchmark index by purchasing bonds in the 10-year and 30-year tranches in France and the UK, mainly.

We are maintaining the rest of the portfolio structure in favor of higher carry. We remain overweight in Italy and France compared to countries such as Portugal, Spain, and Germany. In France, we will continue to monitor the current political situation with the aim of managing the portfolio's exposure to the region. We have taken the opportunity to reduce our weighting in the US following the latest employment data published in early August, and we are maintaining full hedging of dollar-denominated assets to avoid EUR/USD currency risk.


